- **3)** A motion was made by Ms. Mitchell and seconded by Mr. Rohsler to approve the District FY21 Budget.
- 4) Mr. Caruso reported that he had responded to the draft MOA with NRCS and indicated that the Board would be agreeable to signing upon review of the final document.

VIII. NEW BUSINESS

- 3) Mr. Caruso gave an update report on the State's recent "Dirty Dirt" Law.
